*The introduction of the SCIP Database, Substances of Concern In articles as such or in complex objects (Products) supports the implementation of the EU Action Plan for the circular economy.*

*The SCIP Database has been established by ECHA based on the Waste Framework Directive 2008/98/EC. As of January 5, 2021, companies that produce, import or supply articles containing Candidate List substances (SVHC - Substances of Very High Concern) on the EU market have to submit information on these articles to ECHA using a file (so-called dossier).*

*We inform you comprehensively on how to prepare a SCIP Dossier in practice and how to fulfill your notification duty.*

### Objective

You know the SCIP notification process as well as how to use ECHA IT tool IUCLID and can work offline, online or in your own IT system in IUCLID format. You have learned how to access ECHA's services and applications.

You are familiar with the data submission options and can plan the preparation of SCIP Dossiers for your products. You know the information requirements for SCIP Dossiers and can fill out the mandatory and optional fields.

You have a good grasp of the IUCLID features (e.g. Grouping), you can create dossiers and submit them to ECHA.
